- 2. Competition is open to all pianists, without age limit, who are willing to apply and perform in Vienna or online, at the same time with possibility to take part in the Global Finals in Milano, Italy,**
- 3. Taking part is possible both online and in person. Online applicants need to send YouTube link / links to their recording. In the *Piano Concerto and Four hands/ Two Pianos* Categories, only online application is possible.**
- 4. On 8.08.2024 there will be Laureates Gala Concert and Award Ceremony for all the Participants taking part in the Regional Competition.**
- 5. As a prizes there will be cash prizes (Grand Prize winners), invitations to Concerts in Europe, Canada and China, free masterclasses with renowned Professors.**

Additional Regulations

1. The final round for the IV Aegio International Piano Competition will be held in person in Milan, Italy - 27th of July 2024. Participants of the Regional Competition in Vienna will be awarded with prizes and some of them will be qualified to the finals (with participation up to their will)
2. The application deadline for live competition - 25.05.2024, online competition - 19.06.2024. Results - 30.06.2024.
3. This deadline includes the completion of payment of the application form and registration fees. Following the application deadline, the application and registration fees will be non-refundable.
4. In case there will be less than 10 participants for the live audition, Regional Competition will be switched to the online mode for all the participants. All prizewinners will be after invited for a Gala-Concert on 8th August 2024 which will take place in Feurich Performing Hall.
5. All performances in-person or online must be performed from memory. No usage of scores is allowed.
6. The IV Aegio International Piano Competition reserves the rights to publish the contestant's photos and videos for any use, including promotion (once submitted), and will not provide remuneration to contestants for such use. Contestants waive all rights and claims to the use of the submitted videos and photos contained in their application.
7. The IV Aegio International Piano Competition will not be responsible for accommodation or airfare in connection with any performance/recital awarded to a contestant as a result of their participation in this competition.
8. First, Second, and Third Prizes will be awarded for each category. Tied prizes will be awarded at the jury's discretion. The competition will award grand prize winners. Each participant will receive a participation certificate. Decisions by the jury are final and unappealable.
